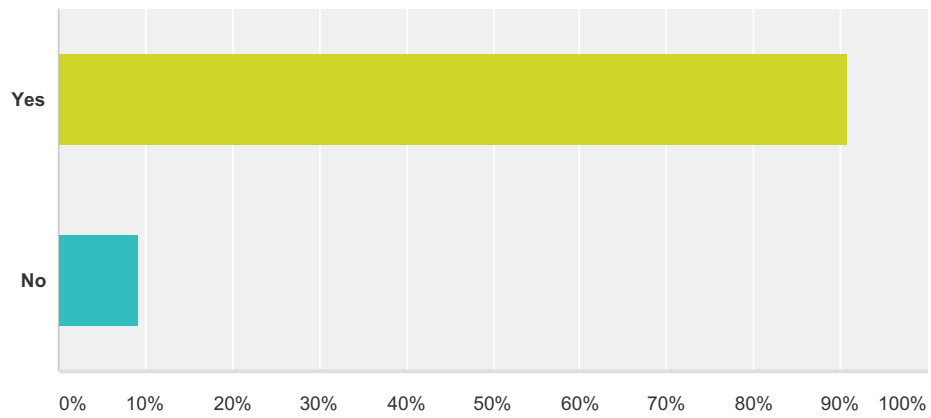


Q1 Were the objectives as listed in the agenda accomplished?

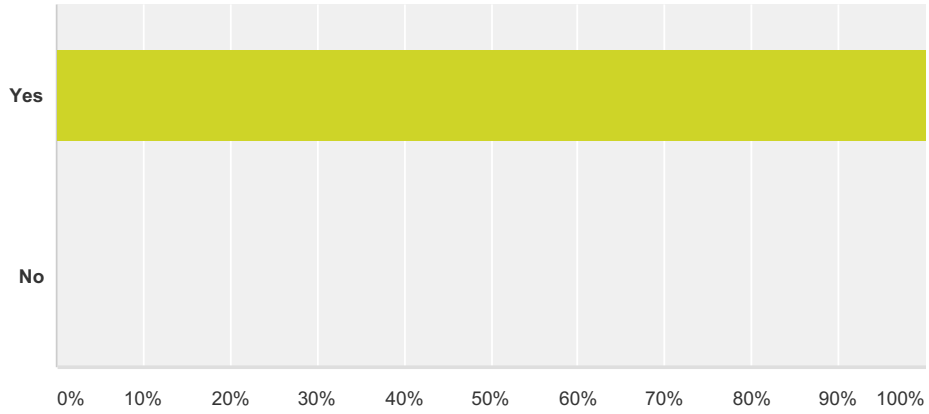

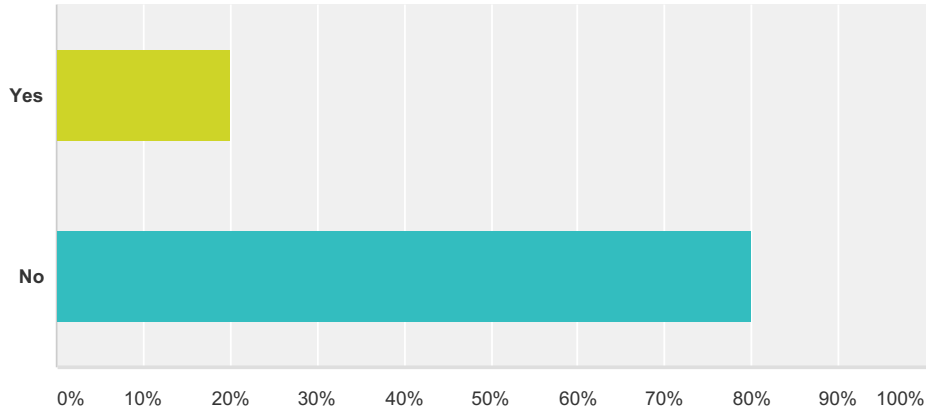
