



1	I was generally satisfied with the directions provided by the board, one area that I think needs some review and improvement is incorporating a positive feedback loop on results. The board and project team members donate a lot of time and energy and deserve some feedback as to improvements in ambient air quality, or other suitable metrics, to assess the effectiveness of project teams and reports over an appropriate time lag. Basing performance measurement strictly on internal parameters is misleading and a waste of participants time. It is not always easy to identify metrics that are measurable but usually if numeric results are not available performance based metrics can be developed for example if a sector did not have a BMP in place as recommended by a project team, a relevant metric may be the number of BMP's initiated as a result of a report, viewed against complaints frequency.
