Current Airshed Plans & Initiatives

Alberta Capital Airshed Alliance ACAA

- Name change (Alberta Capital Airshed Alliance), Society name remains the same (ACAS)
- Stantec working on recruiting membership and business plan
- ► Focus conducting emissions inventory

Calgary Region Airshed Zone CRAZ

- ► The first Annual General Meeting of CRAZ was held May 24, 2007 with CASA facilitating the meeting
 - 28 organizations (including 3 public members) joined the society
 - 12 of 15 board seats filled, with possibility of 2 more soon
 - next step select executive
 - executive director in 2007?
- Proposed boundaries are CHR less PAMZ; consensus not yet achieved
- Feasibility assessment conducted by Amarok & Focus will be used as information for design of monitoring program and funding formula
- Stantec was hired to consult with local stakeholders prior to AGM & determine their interest in participating in CRAZ.
- CRAZ received an \$85,000 AENV grant for operation of stations in 2007-08 Budget Year

Fort Air Partnership -FAP

- Strategic Air Monitoring Plan being Developed
 - In preparation for industrial growth in the area
 - Regional Emissions Inventory and Model are important first steps.
- Regional Air Dispersion Model and Emissions Inventory
 - Consistent database, available to anyone, to be kept "up to date" by FAP is nearly completed.
- New Monitoring Activities:
 - Adding a new continuous station near Bruderheim, and several passive stations to our 40-station passive network
 - Reporting continuous BTEXS measurements (benzene, toluene, ethelbenzene, xylene, styrene)
 - Supporting lichen monitoring program
- Ozone Management Plan development in early stages of discussion
 - Using AEnv Portable Air Monitoring Laboratory (PAML) at site adjacent to Edmonton to look at trans-boundary influences
- Communications activities
 - Participating in Industrial Heartland Committee to Address Resident Issues relating to air quality

Lakeland Industry & Community Assn LICA

- Alberta Environment has approved the AEPEA amendment application (replaces some industries' fence line monitoring requirements with regional monitoring requirements through the LICA Airshed Zone)
- Approval appealed by 3 of the parties who had submitted statements of concern delaying plans to fully implement LICA's continuous monitoring program.
- Background station will be located outside airshed zone but within proposed expanded LICA boundary
- Investigating establishment of VOC monitoring program
- Investigating vehicle emissions clinic; received grant from Aspen Regional Health Authority to carry out this project
- The "Exploratory Study of Potential Acidification Impacts on Soils and Surface Water Within the LICA Area" is complete; final report will be released shortly
- Regional Monitoring Network Review project was awarded jointly to Stantec and RWDI (with expertise from UBC); stakeholder workshop is planned for June 27th
- Rebuilt and re-launched the raw data access website

Palliser Airshed Society PAS

- ▶ PAS Zone Expansion
 - Boundaries coterminous with Palliser Health Authority
 - Continued work engaging stakeholders in the area
 - Preparation of joint application for rationalization of stakeholders' current fenceline air monitoring requirements
 - Implement expanded air monitoring plan
 - one portable continuous monitoring station (6 month schedule)
 - twenty station passive monitoring network (NO2, O3, SO2)
- > 2007 Communication Plan
 - Southern Alberta Environmental Summit
 - City of Medicine Hat Environmental Strategy Advisory Group
 - City of Medicine Hat Environmental Brand Focus Group
 - Annual Environmental Week Trade Fair in Medicine Hat

Parkland Airshed Management Zone PAMZ

- Ozone Management Planning Committee currently reviewing air quality management plans of other jurisdictions. Data needs sub-group assembling inventory of monitoring and modeling in PAMZ and surrounding regions.
- ► Request to AENV for PAML to monitor O₃ east of PAMZ in Stettler area turned down
- PAMZ withdrew its participation and support from Community Health Assessment & Monitoring Program (CHAMP) in March. Human Health Committee now investigating other opportunities
- Mercury Deposition Sampling Program partnership with Canadian Geological Survey continues at Crossfield-Carstairs site
- Conducting SO₂ monitoring program in Tay River Area in partnership with Shell, Keyera and Husky
- Conducting PM sampling program in Sundre area in partnership with Sundre Forest Products

Peace Airshed Zone Association PASZA

- Continue discussions with stakeholders in proposed expansion areas north of Peace River and west of forestry trunk road to ascertain interest in membership
- Extending passive monitoring network into proposed expansion areas (+15)
- Considering addition of some H2S passives to network
- Application made to AENV for PAML in fall to characterize emissions in Girouxville area (large # hog farms)
- Petitioning NRCB to take action on Girouxville hog barns given data presented in AENV's air quality survey of the area (numerous H2S exceedences)
- Rover station slated to move from Falher to Spirit River area this summer, NO2 monitor added
- Communication committee reinstated, after growing concern over expansions and proposed new facilities
- Governance Committee struck to revisit the Society's by-laws and policies; changes are required in the post-Ludwig era

West Central Airshed Society WCAS

- Recommissiong of Hightower background station almost complete; relies on wind & solar power with internal heating from instrumentation itself
- Working with local oil and gas industry and residents to develop a cost-efficient monitoring program to create an intensive 'early warning system' providing data at very low levels of hydrogen sulphide "Sentinel Monitoring Program"
- ► Failure to determine source of recent H₂S odours in area has increased local interest in the program
- Discussions of expansion of boundary north into Whitecourt area, put on hold for at least a year due to focus on other programs
- New communications consultant hired

Wood Buffalo Environmental Assn WBEA

- Revamping WBEA Database
 - Database hardware, software and licensing purchased
 - Meeting with key stakeholders/end-users to ascertain needs
 - Intent is to automate some current processes and improve access
- A task group will review the location of community stations and criteria for siting stations given the expansion and development planned in region
- ► Human Exposure Monitoring
 - 2005 results for Fort Chipewyan and Fort McMurray are now available
 - 2006 results for Fort McKay and Fort McMurray First Nations Anzac/Gregoire Lake will be available shortly
- WBEA is currently reviewing its Vision, Mission, Values, and Strategic Goals.
