  - Alberta Water Council (provincial)


### About the Alberta Water Council

- A multi-stakeholder partnership of 24 industry,
   NGO, and government sectors with an interest in water
- Uses consensus decision making
- In 2007, the Council transitioned to become a not-for-profit society
- Where possible was modeled after CASA

  - Safe, secure drinking water
  - Healthy aquatic ecosystems
  - Reliable, quality water supplies for a sustainable economy
- Monitor and report on implementation progress of the Water for Life strategy
- Develop water policy recommendations
